Since the overturning of *Roe v. Wade* in June 2022, abortion laws and access to care have varied substantially from state to state. Some have taken steps to safeguard, and others to restrict, abortion rights and access during that time. In states across the country, voters have also shifted the conversation, voting again and again to maintain and codify the right to abortion in their states.

As we face an unprecedented reproductive health care crisis nationwide, the Congressional Reproductive Freedom Caucus (RFC), formerly Pro-Choice Caucus, is fighting with you and for you. RFC is a group of over 160 Members of the U.S. House of Representatives committed to advancing reproductive rights, freedom, and justice. From moving key legislation forward to amplifying the voices of those around the country demanding action, RFC Members, led by Co-Chairs Diana DeGette (CO-01) and Ayanna Pressley (MA-07) are proud to fight for your reproductive freedom and bodily autonomy.

That is why, in the wake of the 51st anniversary of *Roe v. Wade*, we launched the Know Your Rights Project—to equip our Members with the tools to share comprehensive, current, and community-specific resources with every constituent they serve to help them know their rights and access care and coverage.

We know that abortion care is health care. Reproductive rights are human rights, and you deserve the freedom to make your own medical decisions—including about abortion.
